Finance Report January 2023

Bank Account Balances:

Outstanding Checks: Checking Account- Elevator and Insurance Bills Totaling \$1685.00

Overdraft Fee: Checking Account \$5.00 on Jan 1, 2023.

Deposited was said to have occurred by Lounge Manager on Dec 22 and Dec 28, 2022; no deposit occurred in Checking Account. Deposit of \$1000.00 occurred on Jan 2, 2023. Lack of deposits caused the overdraft fee and automatic transfer from Building Account of \$246.96. Insufficient funds for Check Number 28115: City of Centralia for \$832.24.

Checking account will still be short by \$316.00 when Insurance and Elevator checks try to clear the Checking Account if no other purchases are made.

Requests:

- That all deposits are taken to the bank by Finance Officer/ Assistant Finance Officer and receive a deposit receipt to reconcile accounts. Deposit slips and receipts are needed to track income and expenses.
- 2. Purchase drop safe with record of money being deposited in safe with report from POS or Kitchen.
- 3. Purchase special envelopes for safe deposits.

Requests can take place after financial review is received by Post Executive Board.
